AS vis a vis Ind AS: Differences in Presentation of Financial Statements, Accounting Policies, Disclosures etc.

With the onset of Ind AS, there has been the introduction of 'Division 2 to the Schedule III' of the Companies Act, 2013. The reason being, Ind AS based Financial statements significantly differ in terms of disclosures from the AS based Financial Statements.



A few typical instances include:


1. Ind AS 1 requires the classification of expenses by Nature. There was no express guidance in AS 1 in this regard.

Although, there is no guidance under AS, the Schedule III to Companies Act is drafted in a manner which permits only nature wise classification of expenses on the face of the Profit & Loss.





2. While there was no guidance in AS 1, there is a requirement for an entity to disclose an **Explicit Unreserved Statement** under Ind AS-1, about its compliance with all Ind AS.



3. Consider a situation where due to boom in the automobile industry, there is upward revaluation in a PPE of the entity. Is this revaluation also, not an income?

Yes, it is unrealised and not distributed, but there seems no reason to warrant its non-disclosure to the shareholders. There has been an appreciation in the value of the assets. So, it needs to be disclosed to the shareholders, however not as PAT.

- 4. AS based FS always had these disclosures relating to 'extra-ordinary' (example, Insurance claims, sale of business etc.) Ind AS have in entirety scrapped off the line item of extraordinary items.
- **5.** Comparability' is an essential characteristic of financial statements. In a case where there are prior period errors or changes in accounting policies which are material, AS required an adjustment directly in the current year figures. Ind AS in keeping with 'comparability', requires a 'retrospective restatement of financial statements.'

Drafting of Partnership Deed and Online Registration of Partnership Firms in Goa.

Introduction:

A partnership firm is a fairly common constitution in Businesses. The law relating to partnership firms is governed by The Indian Partnership Act, 1932 (Hereinafter referred to as "The Act"). The name of the firm, address, nature of business, terms and conditions between the partners are stated in a document named partnership deed. It is not necessary that partnership deed is to be in a written format as per The Act. However, neither can an oral agreement be used as a legal document if any dispute arises, nor does it carry any value for tax purposes. Similarly, registration is also voluntary as per the Act. However, the consequences of non-registration of a firm are:

- 1. No suit in a civil case can be filed by the firm or partners of the firm against any third party;
- 2. No relief to partners for set-off claims;
- 3. An aggrieved partner cannot bring legal action against any other partner of the firm; and
- 4. A third party can sue the firm.

Hence, in view of the above, it is advisable to have a partnership Deed in written format as well as register the partnership firm.

Documents required for Drafting of Deed and Registration of Firm:

The following documents are required:

- 1. Passport size photos of all partners;
- 2. Identity proof of all partners;
- 3. Address Proof of all partners;
- 4. Copy of Aadhaar Card of all partners, if it has not been provided as proof of Address and Identity; and
- 5. Copy of PAN card of all partners.

Drafting of Deed of Partnership:

The deed of partnership should be drafted on non-judicial stamp paper of requisite amount and Legal paper for any additional sheets. Determination of Stamp Duty is done based upon the amount of Capital brought in by the partners. The heading" DEED OF PARTNERSHIP" should be written on the first page in Bold Capital Letters. The Deed should contain the following details:

- 1. Names of Partners, Father's name, Nationality, Age, Residential Address, Aadhaar Number and PAN;
- 2. Name and Address of the firm;
- 3. Nature of Business proposed to be undertaken;



- 4. Date of commencement of partnership business and duration of the partnership firm;
- 5. Amount of Capital brought in by the partners;
- 6. Rate of Interest on capital;
- 7. Salary or Remuneration to Partners and Ratio in which it will be shared;
- 8. Profit or Loss Sharing Ratio;
- 9. Other terms and conditions, including how decisions will be taken and how disputes will be resolved.

Once the deed is drafted, it has to be signed on all pages by the partners. A copy will have to be made, and notarized by a Public Notary. This copy will be scanned and saved in PDF format to be uploaded as discussed later in the next paragraph.

Online Registration of Firm:


A partnership firm has to be registered online with the Civil Registrar in the taluka in which the registered address of the firm is situated. An email address for the firm has to be created, and the same has to be registered as Login ID on the website "partnership.goa.gov.in."

Once you have logged in, the following documents have to be uploaded on the website:

- 1. Scanned copy of the notarized deed of partnership, as referred above;
- 2. Statement required under section 58 and Rule No 5(2) of the Indian Partnership Act in Form No II;
- 3. Proof of Identity and Address of all partners.

Upon verification of the Documents uploaded, the Sub Registrar shall generate a challan for the appropriate amount towards registration fees. The fees will be paid online, and upon receipt of the fees, the Sub Registrar shall register the firm and generate the Registration certificate, which shall be communicated on the email address given in the application.




