DIRECT TAX & CORPORATE LAW UPDATES

Given below are summarised versions of certain important Circulars / Notifications / Press Releases for September 2023 issued by the Central Board of Direct Taxes (CBDT) for the general information of members. Readers are requested to use the website links / QR Codes to access the full text of the desired circular / notification / press release.

Income Tax Updates

- CBDT has extended the due date for furnishing audit report in case of charitable institutions in Form 10B/Form 10BB for Financial Year 2022-23 to 31st October, 2023. Further the due date for furnishing Return of Income in Form ITR-7 for Assessment Year 2023-24 has also been extended to 30th November, 2023.
- CBDT has amended Rule 11UA of the Income Tax Rules for determining fair market value of unquoted equity shares for the purpose of Section 56(2)(viib) of the Act.

The key highlights of the changes in Rule 11 UA are:

- a) In addition to the two methods for valuation of shares, namely, Discounted Cash Flow (DCF) and Net Asset Value (NAV) method, available to residents under Rule 11UA, five more valuation methods have been made available for non-resident investors, namely, Comparable Company Multiple Method, Probability Weighted Expected Return Method, Option Pricing Method, Milestone Analysis Method, Replacement Cost Method.
- b) Where any consideration is received for issue of shares from any nonresident entity notified by the Central Govt., the price of the equity shares corresponding to such consideration may be taken as the FMV of the equity shares for resident and nonresident investors, subject to the following: (i) To the extent the consideration from such FMV does not exceed the aggregate consideration that is received from the notified entity, and (ii) The consideration has been received by the company from the notified entity within a period of ninety days before or after the date of issue of shares which are the subject matter of valuation.
- c) On similar lines, price matching for resident and non-resident investors would be available with reference to investment by Venture Capital Funds or Specified Funds.
- d) Valuation methods for calculating the FMV of Compulsorily Convertible Preference Shares(CCPS) have also been provided.
- e) A safe harbor of 10% variation in value has been provided.



· CBDT has introduced a revised procedure, format and standards for filing applications for the grant of certificates required for deduction of income tax at lower rates or for no deduction of income tax.

MCA Updates

• The Ministry of Corporate Affairs vide its General Circular No 9/2023 dated 25.09.2023 has allowed the Companies whose AGMs are due in the year 2023 or 2024, to conduct their AGMs through VC or OAVM on or before 30th September 2024 in accordance with the requirements laid down in Para 3 and Para 4 of the General Circular No. 20/2020 dated 05.05.2020. It has further been clarified that the aforementioned extension shall not be construed as conferring any extension of statutory time holding of AGMs by the companies under the Companies Act, 2013.

GST NOTIFICATIONS FOR THE MONTH OF AUGUST & SEPTEMBER 2023

Notification No 36/2023 dated 04-08-2023 - Central Tax

In exercise of the powers conferred by section 148 of the Central Goods and Services Tax Act,2017 (12 of 2017), the Central Government hereby notifies the electronic commerce operator who is required to collect tax at source under section 52 as the class of persons who shall follow the following special procedure in respect of supply of goods made through it by the persons paying tax under section 10 of the said Act, namely

- The electronic commerce operator shall not allow any inter-State supply of goods through it by the said person;
- 2. The electronic commerce operator shall collect tax at source under sub-section (1) of section 52 of the said Act in respect of supply of goods made through it by the said person and pay to the Government as per provisions of subsection (3) of section 52 of the said Act and
- The electronic commerce operator shall furnish the details of supplies of goods made through it by the said person in the statement in FORM GSTR-8 electronically on the common portal.
 - This notification shall come into force with effect from 01-10-2023.

Notification No 37/2023 dated 04-08-2023 - Central Tax

In exercise of the powers conferred by section 148 of the Central Goods and Services Tax Act, 2017 (12 of 2017), the Central Government hereby notifies the electronic commerce operator who is required to collect tax at source under section 52 as the class of persons who shall follow the following special procedure in respect of supply of goods made through it by the persons exempted from obtaining registration in accordance with the notification issued under sub-section (2) of section 23 vide notification number 34/2023- Central Tax, dated the 31st July, 2023, namely

- The electronic commerce operator shall allow the supply of goods through it by the said person only if enrolment number has been allotted on the common portal to the said person;
- 2. The electronic commerce operator shall not allow any inter-State supply of goods through it by the said person
- 3. The electronic commerce operator shall not collect tax at source under subsection (1) of section 52 in respect of supply of goods made through it by the said person and
- 4. The electronic commerce operator shall furnish the details of supplies of goods made through it by the said person in the statement in FORM GSTR-8 electronically on the common portal.



Where multiple electronic commerce operators are involved in a single supply of goods through electronic commerce operator platform, "the electronic commerce operator" shall mean the electronic commerce operator who finally releases the payment to the said person for the said supply made by the said person through him.

This notification shall come into force with effect from 01-10-2023.

Notification No 38/2023 dated 04-08-2023 - Central Tax

Notification No 39/2023 dated 04-08-2023 - Central Tax

In exercise of the powers under section 3 read with section 5 of the Central Goods and Services Tax Act, 2017 (12 of 2017) and section 3 of the Integrated Goods and Services Tax Act, 2017 (13 of 2017), the Central Government, hereby makes the following further amendments in the notification no 2/2017 - Central Tax dated 19-06-2017, namely

- for serial number 39 and the entries relating thereto, the following serial number and entries shall be substituted and shall be deemed to have been substituted, namely 39 -Guntur - Districts of West Godavari, Krishna, NTR, Eluru, Guntur, Bapatla, Palnadu, Prakasam, SPS Nellore, mandals of Kovvur, Chagullu, Tallapudi, Nidadavole, Undrajavaram, Peravali, Devarapalle, Gopalapuram and Nallajerla of East Godavari District and mandals of Gudur, Chillakaur, Kota, Vakadu, Chittamur, Balayapalli, Venkatagiri, Dakkili, Ozili, Naidupet, Pellakur, Doravarisatram, Sullurpeta and Tada of Tirupati District in the state of Andhra Pradesh.
- 2. For serial number 101 and the entries relating thereto, the following serial number and entries shall be substituted and shall be deemed to have been substituted, namely:-101 Tirupati Districts of Chittoor, YSR Kadapa, Anantpur, Annamayya, Sri Satyasai, Nandyal, Kurnool and mandals of Buchi Naidu Kandriga, Varadaiahpalem, Satyavedu, Srikalahasti, Thottambedu, Renigunta, yerpedu, Kumara Venkata Bhupala Puram, Nagalapuram, Pichatur, Narayanavanam, Tirupati Urban, Tirupati Rural, Chandragiri, Pakala,Ramachandrapuram, Vadamalapet, Puttur, Yerravaripalem and Chinnagottigallu of Tirupati district in the State of Andhra Pradesh.
- 3. For serial number 107 and the entries relating thereto, the following serial number and entries shall be substituted and shall be deemed to have been substituted, namely:- 107 Visakhapatnam In the Districts of Srikakulam Vizianagaram, Visakhapatnam, Anarkapalli, Alluri Sitaramaraju, Parvatipurammanyam, Dr. B.R. Ambedkar Konaseema, Kakinada and mandals of Rajamahendravaram Urban, Rajamahendravaram Rural, Kadiam, Rajanagaram, Seethanagaram, Korukonda, Gokavaram, Anaparthi, Biccavolu and Rangampeta of East Godavari District in the State of Andhra Pradesh."



Notification No 41/2023 dated 25-08-2023 - Central Tax

In exercise of the powers conferred by the proviso to sub-section (1) of section 37 read with section 168 of the Central Goods and Services Tax Act, 2017 (12 of 2017), the Commissioner hereby makes the following further amendment in the notification no 83/2020 dated 10-11-2020 namely

- 1. for the words, letter and figure tax periods April 2023, May 2023 and June 2023, the words, letter and figure tax periods April 2023, May 2023, June 2023 and July 2023 shall be substituted.
- 2. for the words, letters and figure thirty-first day of July, 2023, the words, letter and figure twenty-fifth day of August, 2023 shall be substituted.

This notification shall come into force with effect from 31-07-2023.

Notification No 42/2023 dated 25-08-2023 - Central Tax

In exercise of the powers conferred by sub-section (6) of section 39 of the Central Goods and Services Tax Act, 2017 (12 of 2017), the Commissioner, hereby makes the following further amendment in the notification no 12/2023 dated 24-05-2023, namely

- 1. For the words, letter and figure tax periods April 2023, May 2023 and June 2023, the words, letter and figure tax periods April 2023, May 2023, June 2023 and July 2023 shall be substituted.
- 2. For the words, letters and figure thirty-first day of July, 2023, the words, letter and figure twenty-fifth day of August, 2023 shall be substituted.

This notification shall come into force with effect from 31-07-2023.

Notification No 43/2023 dated 25-08-2023 - Central Tax

In exercise of the powers conferred by sub-section (6) of section 39 of the Central Goods and Services Tax Act, 2017 (12 of 2017), the Commissioner, hereby makes the following amendment in the notification no. 20/2023 - Central Tax, dated the 17th July, 2023 namely

- For the words, letters and figure -thirty-first day of July, 2023, the words, letter and figure -twenty-fifth day of August, 2023 shall be substituted.

This notification shall come into force with effect from 31-07-2023.

Notification No 44/2023 dated 25-08-2023 - Central Tax

In exercise of the powers conferred by sub-section (6) of section 39 read with section 168 of the Central Goods and Services Tax Act, 2017 (12 of 2017), the Commissioner, hereby makes the following further amendment in the notification no 26/2019 dated 28-06-2019, namely

1. For the words, letter and figure -tax periods April 2023, May 2023 and June 2023, the words, letter and figure -tax periods April 2023, May 2023, June 2023 and July 2023 shall be substituted.



2. For the words, letters and figure -thirty-first day of July, 2023, the words, letter and figure -twenty-fifth day of August, 2023 shall be substituted.

This notification shall come into force with effect from 31-07-2023.

Notification No 45/2023 dated 06-09-2023 - Central Tax

In exercise of the powers conferred by section 164 of the Central Goods and Services Tax Act, 2017 (12 of 2017), the Central Government hereby makes the following rules further to amend the Central Goods and Services Tax Rules, 2017, namely:

31B. Value of supply in case of online gaming including online money gaming

Notwithstanding anything contained in this chapter, the value of supply of online gaming, including supply of actionable claims involved in online money gaming, shall be the total amount paid or payable to or deposited with the supplier by way of money or money's worth, including virtual digital assets, by or on behalf of the player:

Provided that any amount returned or refunded by the supplier to the player for any reasons whatsoever, including player not using the amount paid or deposited with the supplier for participating in any event, shall not be deductible from the value of supply of online money gaming.

31C. Value of supply of actionable claims in case of casinos

Notwithstanding anything contained in this chapter, the value of supply of actionable claims in casino shall be the total amount paid or payable by or on behalf of the player for -

- (i) purchase of the tokens, chips, coins or tickets, by whatever name called, for use in casinos: or
- (ii) participating in any event, including game, scheme, competition or any other activity or process, in the casino, in cases where the token, chips, coins or tickets, by whatever name called, are not required.

Provided that any amount returned or refunded by the casino to the player on return of token, coins, chips, or tickets, as the case may be, or otherwise, shall not be deductible from the value of the supply of actionable claims in casinos.

Notification No 47/2023 dated 25-09-2023 - Central Tax

In exercise of the powers conferred by section 148 of the Central Goods and Services Tax Act,2017 (12 of 2017), the Central Government, hereby makes the following amendments in the notification No. 30/2023-Central Tax, dated the 31st July, 2023 namely:-

In the said notification, after the words "hereby notifies the following special procedure to be followed" the words and figures "with effect from 1st day of January 2024" shall be inserted and shall be deemed to have been inserted with effect from the 31st July 2023.

Notification No 48/2023 dated 29-09-2023 - Central Tax

In exercise of the powers conferred by sub-section (2) of section 1 of the Central Goods and Services Tax (Amendment) Act, 2023, the Central Government hereby appoints the 1st day of October, 2023, as the date on which the provisions of the said Act, shall come into force.



Notification No 49/2023 dated 29-09-2023 - Central Tax

In exercise of the powers conferred under sub-section (5) of section 15 of the Central Goods and Services Tax Act, 2017 (12 of 2017), the Government, on the recommendations of the Council, notifies the following supplies under the said sub-section, namely —

- (i) supply of online money gaming;
- (ii) supply of online gaming, other than online money gaming; and
- (iii) supply of actionable claims in casinos.

This notification shall come into force on the 1st day of October, 2023.

Notification No 50/2023 dated 29-09-2023 - Central Tax

In exercise of the powers conferred by section 148 of the Central Goods and Services Tax Act, 2017 (12 of 2017), the Central Government hereby makes the following amendment in the notification no. 66/2017-Central Tax, dated the 15th November, 2017 namely —

In the said notification, with effect from the 1st October, 2023, after the words and figures "composition levy under section 10 of the said Act", the words and figures ", other than the registered person making supply of specified actionable claims as defined in clause (102A) of section 2 of the said Act." shall be inserted.

Notification No 51/2023 dated 29-09-2023 - Central Tax


